Our summer staff employees serve in a variety of roles throughout the summer and throughout each work day. A typical day will include several of the following:

- Providing face-to-face customer service to campers, parents, and faculty in a courteous manner
- Facilitating games and initiatives (with appropriate training provided)
- Lifeguarding at pool and waterfront locations (with appropriate training provided)
- General maintenance tasks, including hauling trash, mowing/trimming, and minor repairs to structures
- Food preparation, service, and dish washing in a commercial kitchen environment, maintaining proper food safety (with appropriate training provided)
- General housekeeping tasks, including sweeping, mopping, and cleaning bathroom areas
- Serving food and drink items in the Pop Shop
- Setting up for camper activities, including lifting up to 40 lbs. up to twenty times daily
- Miscellaneous office tasks, including copying, sorting, and organizing
- Other tasks as assigned by Mahoning Valley year-round employees
